Location

The unit is located on the newly established T54 Business Park, just off the A464 dual carriageway and within one mile of Junction 4 of the M54 motorway, linking to the wider West Midlands motorway network. Surrounding occupiers include Cosma Casting UK, AXYZ, Filtermist, Polytec Group and Torus Group. Telford Town Centre is within two miles offering extensive amenities.

Description

The building comprises a unit of 1,630m² /17,545ft² GIA to be let as one unit. The building has a pitched roof with an eves height of 8m and is constructed of a steel frame with clad elevations. The building has been constructed to shell and core with an element of office space. There are two flat access loading doors to the rear.
